



Facility Waiver, Terms of Use, and Conduct Policy

I, the undersigned, wish to participate in activities at Love Padel Club in Kutaisi, Georgia. By signing this document, I acknowledge and agree to the following:

1. General Liability Waiver

1. I participate voluntarily in padel and related activities at my own risk.
2. I acknowledge that using the club facilities involves inherent risks, including injury, illness, slips, falls, or equipment-related accidents.
3. I release, waive, and hold harmless Love Padel, its owners, staff, instructors, and affiliates from any claims, liabilities, or damages arising from my participation, including claims resulting from negligence.
4. I assume responsibility for my own health, medical needs, and insurance coverage.
5. I consent to emergency medical treatment if deemed necessary by club personnel or emergency services.

2. Facility Terms of Use

1. Members and guests must follow all club rules, staff instructions, and posted safety guidelines.
2. Use of the club is only permitted during official hours.
3. Players must respect equipment, courts, and property; damage caused by negligence may result in fees.
4. Food and drinks are only allowed outside of the courts.

3. Facility Rules

1. Players must use appropriate sports clothing and footwear.
2. All guests are expected to behave respectfully toward others.
3. Harassment, abusive language, or inappropriate conduct will not be tolerated.
4. The club reserves the right to remove any individual from the premises for misconduct or unsafe behaviour.
5. Smoking is only permitted outdoors.

I have read, understood, and voluntarily agree to abide by this waiver, terms of use, and conduct policy.

Booking Disclaimer

1. Booking & Payment Policy

1. All court bookings must be made in advance through our booking system or directly at the club.
2. Full payment may be required at the time of booking unless otherwise agreed.
3. Bookings are subject to availability and confirmation by the club.

2. Cancellation & Rescheduling Policy

1. Cancellations or rescheduling requests must be made at least 24 hours before the scheduled booking time.
2. Cancellations made more than 24 hours in advance are eligible for:
 - Credit toward a future booking (club discretion).
3. Cancellations made within 24 hours of the booking time, or failure to attend (“no-show”), are not eligible for a refund or credit.
4. In exceptional circumstances (e.g. severe weather, facility issues), the club reserves the right to reschedule or refund bookings.

3. Late Arrival Policy

1. Late arrivals will not receive extended playing time.
2. The booking will end at the originally scheduled time to respect subsequent bookings.

4. Participation at Own Risk

1. Padel is a physical sport that involves inherent risks, including but not limited to slips, falls, collisions, muscle injuries, or equipment-related injuries.
2. By booking and/or participating, the player voluntarily assumes all risks associated with playing padel.

5. Liability Waiver & Release

1. The participant releases and discharges the padel club, its owners, employees, coaches, contractors, and affiliates from any liability for injuries, damages, or losses sustained while using the facilities or participating in activities.
2. This waiver applies to personal injury, property damage, or loss, whether caused by negligence or otherwise.
3. The participant agrees that the club is not responsible for lost, stolen, or damaged personal belongings.

6. Health & Fitness Declaration

1. The participant confirms they are in good physical condition and have no medical condition that would prevent safe participation.
2. The participant agrees to stop playing immediately if feeling pain, dizziness, or discomfort and to inform staff if assistance is needed.

7. Photography & Media

1. The club may take photos or videos for promotional purposes.
2. If you do not consent, please notify the club in writing prior to your booking.

8. Governing Law

This agreement shall be governed and interpreted in accordance with the laws of Georgia.

9. Acceptance of Terms

By making a booking, entering the premises, or participating in any activity, the participant confirms that they:

- Have read and understood this waiver
- Agree to all terms and conditions
- Accept full responsibility for their participation
